Regulations for public participation

Black Sea Air Show - Constanța 2025, 4th Edition - 02 august 2025

Generalities and organizers

The aviation event "Constanța Black Sea Air Show", the 4th edition, which will take place on August 2, 2025, is organized by **Mihail Kogălniceanu International Airport Constanța**, in partnership with Mihail Kogălniceanu Air Base 57, the Romanian Aeroclub and Eventiland Constanța, with the support of the Ministry of Transport and Infrastructure, the Romanian Air Force, the City Hall of Mihail Kogălniceanu - Constanța and is addressed to the local community, the central region and tourists on the Black Sea coast/the general public.

Date and venue

The event will take place at Mihail Kogălniceanu International Airport Constanța, Str. Tudor Vladimirescu no. 4, Mihail Kogălniceanu, Constanța, on August 02, 2025.

Participation and access

Admission to the event is free. Access for the public and guests will be allowed from 02:00 PM, following the instructions of the A.I.M.K.C., Romanian Gendarmerie and Traffic Police personnel (see Annex 1).

Safety and security rules

Each participant will comply with the instructions and decisions communicated by the event organizer throughout its duration. By being present in the event area, participants undertake to comply with these Regulations, understanding that they are designed exclusively for their safety and comfort.

For the safety of the public and the smooth running of the event, the following measures will be taken:

- in the event of external temperatures/various weather phenomena that may cause thermal discomfort, participants, and especially people with conditions or personal medical history, are asked to take specific protective measures (sunscreen, hat/cap/umbrella, proper hydration, etc.);persoanelor care au probleme de ordin auditiv le este recomandată folosirea dopurilor de protecție pentru urechi;
- bags and packages will not be left unattended, because if they cannot be accurately identified, they will be suspected of causing incidents affecting security;

- participants are asked not to leave minor children unattended; the entire responsibility lies with the accompanying adults;
- smoking (tobacco or electronic cigarettes) is allowed only in specially arranged and marked areas;
- the organizer provides an area arranged for parking cars, within the limits of the available spaces;
- if after the end of the event there are cars left on the area delimited for their parking, they will be picked up and taken to a specially arranged space, the cost of the service being borne by the owner.

The following are prohibited:

- throwing waste of any kind in places other than those arranged by the organizer for selective collection;
- participating in the event while intoxicated or under the influence of any prohibited substances;
- participation in the event by persons who have on them, in plain sight or hidden, alcoholic beverages, psychotropic substances, weapons of any kind, explosive or incendiary materials, irritating-tear-producing substances or substances with a paralyzing effect, or other objects that can be used for violent actions or to disrupt the normal course of the event;
- introducing or displaying inscriptions, banners, placards and other visual elements that incite discrimination of any kind and violence;
 - access with pets;
 - smoking and consuming alcoholic beverages for persons under 18 years of age;
 - crossing the line (physical barrier fence) that delimits the event area.

The organizer reserves the right to restrict access to persons who pose a danger to the safety and comfort of other participants, and if they do not cooperate, the organizer will notify the police.

Filmed and photographed

Photography/filming is permitted in the area where the event is taking place.

Transportation to/from the Airport

Transportation to/from Mihail Kogălniceanu International Airport Constanța is the responsibility of the participants.

Parking is free for event participants within the limits of available spaces.

The organizer is not responsible for personal belongings, valuables left in cars or unattended within the event area.

The organizer does not assume responsibility for any damages suffered as a result of possible road events that occur due to the inattention of drivers.

INFORMATION NOTE ON THE PROCESSING OF PERSONAL DATA

NATIONAL COMPANY "MIHAIL KOGĂLNICEANU-CONSTANȚA INTERNATIONAL AIRPORT" S.A., a Romanian legal entity organized as a joint-stock company, in accordance with the provisions of H.G. 523/1998 updated, with headquarters in CONSTANȚA county, Mihail KOGĂLNICEANU commune, TUDOR VLADIMIRESCU street, no. 4, hereinafter referred to as AIMKC, as the host organizer, addresses this information to you about the processing of your personal data and about your rights under EU Regulation 679/2016.

This information is intended to clarify the purposes, grounds and methods in which AIMKC processes the personal data of the public participants present at the CONSTANŢA BLACK SEA AIR SHOW event, 4th edition, 02.08.2025.

AIMKC is the controller with respect to the processing of personal data of its employees/partners/contractors/visitors, as it determines the purposes and means of processing such data. For the purpose and on the occasion of such processing, AIMKC takes all due care to protect your personal data through measures in accordance with applicable law.

1.Personal data processed

As the host organizer, AIMKC processes the following personal data:

(i) Photo/video images of audience participants.

2. Purpose for which the personal data from Point 1 are processed

AIMKC processes the personal data of the public participants for the purpose of:

- a) <u>To have access to participate on the AIMKC territory at the Constanta Black Sea</u> <u>Air Show event, 4th Edition, organized on 02.08.2025</u>;
 - b) To publicize the event with posts on the owned social networks.

NOTE: images of participants may also be captured by third-party participants in the event, namely, media accredited by AIMKC, flight schools, visitors, etc. and posted in real time or later by them on various social networks or their own websites.

3.Legal basis for processing personal data

The processing of personal data in this context is based mainly on Article 6, paragraph 1, letter c) of EU Regulation 679/2016, in the case of processing of personal data necessary for the fulfillment of a legal obligation incumbent on AIMKC.

AIMKC processes the **personal data of public participants** in full compliance with legal provisions, and these data may be transmitted to third parties only for the purposes mentioned in section 2. In this context, the **personal data of public participants** are or could be communicated to the following recipients:

- (i) central/local public authorities and institutions (police, prosecutors' offices, courts, special services and others);
- (ii) external service providers (if applicable);
- (iii) transport service providers (if applicable).

5. Processing period of your personal data

As a data controller, AIMKC will process the data of the **public participants** provided for in point 1, and by virtue of its legal obligations, AIMKC will store and archive the recorded photo/video images that also contain personal data, in accordance with the legislation in force.

NOTE: You are not obliged to provide the requested data, respectively to accept being filmed/photographed (except for the purpose in point 2.a), but please keep in mind that you are participating in a public event with many external visitors, and the capture of images by them is almost inevitable and no longer falls under the responsibility of AIMKC.

6. Rights of public participants in relation to the processing of personal data by AIMKC

You have the possibility, under certain conditions provided for by the Regulation, to exercise the following rights:

Right of access to data	You have the opportunity to obtain from AIMKC, free of charge, confirmation of the processing of your personal data, as well as access to the data and the information referred to in art. 15 of the GDPR. Please contact us if you would like confirmation that your data is being processed and if you would like to know how it is being managed. The response will be provided within one month of the date of the request (unless the request is unfounded or excessive).
Right to erasure	You may exercise your right to have your personal data erased in a number of situations (for example, if the data is no longer necessary in relation to the purpose for which it was created). Given the purposes and grounds for processing your data detailed above, you may exercise your right to have your data erased under the conditions set out in Article 17 of the Regulation.
Right to restriction of processing	This right may be exercised in the situations and conditions provided for in Article 18 of the Regulation.
Right to data portability	Your data is recorded in physical and/or electronic format, in databases processed manually and automatically. In the event that AIMKC processes personal data concerning you exclusively by automated means, you will have the opportunity to request that

The right not to be subject to a decision based solely on automated processing, including profiling.	AIMKC does not make decisions based solely on automated processing of your personal data nor does it use personal data for profiling.
The right to complain and to address the courts	Under this right, you have the possibility to file a complaint with the ANSPDCP if you consider that the processing of your data does not meet legal requirements, as well as to file court actions regarding your rights.
